In reading history, students engage in cognitive processes of learning, text processing, and reasoning. It then illustrates that students can be exceedingly malleable in their opinions about controversial questions -- and generally quite influenced by the texts they read. And it presents patterns of learning and reasoning within and between

By examining students' ability to use historical documents, this volume goes beyond story learning into the problem of document-based reasoning.
